10TH AFRICAN RIFT GEOTHERMAL CONFERENCE (ARGeo - C10)

Accelerating Development of Geothermal Resources in Africa for Just Energy Transition, Carbon Markets and Net Zero Emissions

1. About ARGeo - C10

The Government of the United Republic of Tanzania, through the Tanzania Geothermal Development Company (TGDC) will be hosting the Tenth African Rift Geothermal Conference (ARGeo-C10) in partnership with UN Environment Programme (UNEP), African Geothermal Association (AGA), and other international partners involved in geothermal energy development. The conference will be held at Julius Nyerere International Convention Centre in Dar es Salaam, Tanzania from 21 – 27 October 2024. The Conference consists of:

- 21 - 22 October 2024: Four Parallel Short Courses.
- 23 - 25 October 2024: The Main Conference
- 26 - 27 October 2024: The Field Excursion.

The Conference will be organized under the auspices of the UNEP Africa Geothermal Development facility Programme (ARGeo) as one of its biennial geothermal conferences. The nine previous biennial conferences were held in Ethiopia (2006), Uganda (2008), Djibouti (2010), Kenya (2012), Tanzania (2014), Ethiopia (2016), Rwanda (2018). The eighth Conference (ARGeo-C8) was held virtually in 2020 and hosted by the Government of Kenya, while ARGeo-C9 was held in 2022 in Djibouti.

The conference will provide opportunities for exhibitors to showcase their projects, products, equipment and services. It will be an opportune time for business networking with lead personalities and institutions in the geothermal sector from Africa and elsewhere in the world.

In order to expedite geothermal development in Africa, various innovative geothermal support programmes have been initiated in the East Africa region. The UNEP -ARGeo Programme is one of the pioneers in the region where its main objective is to catalyse investments in geothermal development in the region. This programme, through one of its project components, supports countries to host and organize the biennial regional geothermal conferences in coordination with other geothermal support programmes and partners. The aim of this biennial conference is to promote regional cooperation, create an information exchange platform on the exploration, development, investment and utilization of the geothermal resources in the region.

TGDC is the state entity that is mandated with geothermal development in Tanzania.

VISA GUIDELINES

IMPORTANT NOTICE:

- i. There are two options to obtain Tanzania Visa. These are **Online Visa Platform and On-Arrival Visa Platform**. This means, after introduction of Online Visa System, Visa are no longer issued at the Embassies;
- ii. The On-Arrival Visa facility may only be used by applicants whose nationalities do not fall under Referral Visa category. Despite having the On Arrival Visa facility, it is recommended for all applicants to use online Visa platform;
- iii. Applicants who wish to use on arrival Visa facility are required to countercheck if their nationalities are not in the list of countries which fall under [Referral Visa category](#);
- iv. Applicants of Online Visa are strongly advised to read carefully the **Visa Guidelines** before making an application;
- v. Online Visa applicants are advised to make their applications through the Official Tanzania Immigration website (www.immigration.go.tz) **ONLY or directly through the link: visa.immigration.go.tz and Not** through any other links;
- vi. Any applicant of Visa is assumed to have **read, understood and agreed** to the **Terms and Conditions** available on the Visa Portal and stipulated in the **Declaration**;
- vii. Applicants must ensure that their passports have a validity of at least *six months* and at least one unused visa page before submitting their application;
- viii. Applicant is expected to apply for a right category of visa. If the applicant is not sure about the type of visa he/she requires, he/she is advised to seek guidance through the e-mail: info@immigration.go.tz
- ix. Visitors who wish to come for **holiday or Tourism** are advised to apply for **Ordinary Visa**. However, **holders of American passports who come for holiday or tourism will have to apply for Multiple Entry Visa**;
- x. Applicants who are Not Americans, and wish to apply for Multiple Visa are **strongly advised to read carefully and observe the requirements** for Multiple Visa,
- xi. Any Visa wrongly applied or which lacks sufficient attachment(s) may be rejected;
- xii. **No refund** will be made in respect of any rejected Visa application;



- xiii. As reflected in the Client Service Charter, the normal Visa applications may be processed within **ten days**. However, some applications as may be determined by the authority, may call for more processing time;
- xiv. After making payments, applicants are required to **wait for approval** of their Visa before they start their journey, even if the stipulated time frame expires;
- xv. Approval notifications will be sent to applicants' e-mails. If for any reason, the applicant does not receive an email notification of Visa approval within the specified time, he may download the **Visa Grant Notice** through the following link:

- xvi. If the Visa is not issued within the specified time frame, applicant may make follow up through the official email: info@immigration.go.tz
- xvii. The Tanzania Immigration Services Department may give or withhold reasons for rejection of Visa to the applicant;
- xviii. Applicants whose nationals fall under **Referral Visa category** are **not eligible for on arrival Visa platform. They must apply Online**. Before getting approval of their Visa, **they are not advised to pay for flight tickets or hotel accommodation**. They may only make flight booking or make hotel reservations; but actual payments should only be done after they get approval for their Visa. Also, such applicants are advised to apply at least 6 weeks before their date of travel;
- xix. The list of countries which fall under **Referred Visa may change** at any time; therefore, applicants are advised to review this list on our website from time to time.
- xx. Visa regulations and conditions may be subject to change at any time without prior notification to the applicants.

Note:

It should be noted that the possession of Visa is not a final authority to enter the United Republic of Tanzania. The Immigration Officer at the Entry point may refuse a holder of Visa to enter, if he is satisfied that the holder is unable to fulfil Immigration entry requirements or if the presence of such person or visitors in the United Republic of Tanzania would be contrary to the National Interests.

Also, Visitors MUST show their Return Ticket upon arrival.
