It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for Execution of the Remaining Construction Works Including Supply, Installation, Testing and Commissioning of the Natural Gas Based 185MW Power Plant Project- Kinyerezi I Extension.
2. Tender was advertised in January 2021 through TANePS but was suspended shortly due to some Legal reasons that was undertaken by the High Court of the United Republic of Tanzania and now the suspension is uplifted to allow continuing with Procurement processes.
